- Legal Will




#### Who Should I Appoint to Act for Me?

- The most ethical person you know.
- Someone who will do what you want.
- The person can live anywhere in the world and there is not requirement to be related



## Capacity

- Determine the possibility of exploitation.
- The more there is, the higher the capacity needs to be.
- If there is not sufficient capacity, must be a Guardianship



## Guardianship

- What is guardianship an involuntary order taking away the power of another to make choices.
- When is it time to consider this decision? When it's too late to do a voluntary Advanced Directive.
- Don't wait --- Act --- prepare in advance!

## What is PACE?

Program of All-Inclusive Care for the Elderly

**Medicare** and **Medicaid** program that gives **community-based care** and services to people 55 or older who would otherwise need **nursing home** level of care.

PACE is an integrated system of care for the elderly that is:

- Community-based
- Comprehensive
- Capitated
- Coordinated



## PACE Philosophy

#### Honoring the wants and needs of frail adults and their families:

- To be cared for in familiar surroundings
- To maintain autonomy of their care
- To maintain a maximum level of physical, cognitive, and social function

The **heart of PACE** is the belief that it is better for the well-being of frail elders with chronic care needs and their caregivers to be served in the community whenever possible



## PACE Background

Existing care models could not serve the older Asian and Pacific Islander American community in their Chinatown North Beach neighborhood homes.

In 1971, the first PACE program opened in San Francisco (On Lok).

Today, there are 186 PACE organizations located in rural areas, inner cities, and the Cherokee Nation Reservation.

These programs empower a diverse range of older adults and those living with disabilities to remain independent as long as possible while living in their homes and communities.



## Who Does PACE Serve?

Participants are eligible to join PACE if they:

- Are 55 years of age or older
- Live in a PACE service area
- Are certified as needing nursing home care
- Are able to live safely in the community with the services of the PACE program at the time of enrollment





## PACE Model of Care

#### PACE IS AN INNOVATIVE MODEL OF CARE



- Interdisciplinary team approach
- Participants receive services in the PACE center and in their homes
- PACE is a Medicare Part D provider and provides all prescription drugs with no benefit limitations, copays, or deductibles



## Additional PACE Services

#### **Other Services Provided**



- Nursing
- Nutritional Counseling
- Social Work
- Medical Care
- Personal Care
- Social Services

- Audiology
- Dentistry
- Optometry
- Podiatry
- Respite Care
- Care Management
- Hospital and nursing home care are provided when necessary.
- Any other care, services or supports deemed medically necessary to maintain or improve the health status of participants.

If a PACE participant needs nursing home care, the PACE program pays for it and continues to coordinate the participant's care.

- PACE enrollees are less likely to suffer depression. A study showed that 27 percent of new PACE enrollees scored as depressed on an assessment administered before enrollment. Nine months later, 80 percent of those individuals no longer scored as depressed.xiv
- Participants rated their satisfaction with PACE as 4.1 out of 5.<sup>xv</sup> The disenrollment rate is almost 5 percent less than Medicare Advantage plans. <sup>xvi,xvii</sup>



#### PACE Place

- PACE Place opened its doors to the Jacksonville community on March 1, 2020
- Not-for-profit corporation formed for the sole purpose of brining PACE to Jacksonville and surrounding areas
- PACE Place is the only PACE program in northeast Florida
- PACE Place started as a joint venture between Community Hospice & Palliative Care and the Aging True
  - PACE Place is now fully owned by Community Hospice & Palliative Care










## Financial Support

#### Credit for Caring Act S.925/H.R. 2036

AARP urges passage of the bipartisan Credit for Caring Act

- Offset the cost of certain caregiving expenses
  - Like home care aides, home modifications, respite care, transportation, etc.
- Tax credit for 30% of qualified expenses
  - ○Up to a maximum of \$5,000





## Lowering Costs for Caregivers Act S. 1565/H.R. 138

AARP urges passage of the bipartisan Lowering Costs for Caregivers Act.

- Allow family caregivers to use pre-tax health expense payment accounts
  - Health savings account, flex spending, Archer medical savings, health reimbursement accounts
  - OParents, parents-in-law, spouses, and dependents

# Alleviating Barriers for Caregivers Act (ABC Act) S. 1227/H.R. 2491

AARP urges passage of the bipartisan ABC Act.

- Reduce the red tape for family caregivers with CMS and SSA
- Require agencies to:
  - Reduce administrative challenges in application and eligibility processes.
  - Seek caregiver input on solutions.
  - Simplify and streamline procedures for family caregivers.

## New Incentives for Employers to Offer Paid Leave Will Help Caregivers



- Makes tax credit permanent.
  - Previous tax credit set to expire at end of 2025.
- Applies to workers after 5 months of employment.
  - Previous minimum employment requirement was one year.




